SECTION 1.1-108

GENERAL PENALTY.

The general penalty charge referenced in Section 1-108 is unless otherwise provided by state law or a specific part of the City Code, a Two Hundred Dollars (\$200.00) fine, plus court costs as set by the City. In addition, the City may make application in the prosecution of any offense for an increased or enhanced penalty upon filing of a separate information or complaint by the City Attorney, in which case said offense shall be punishable by a fine not exceeding Five Hundred Dollars (\$500.00) or thirty (30) days in jail, or both, plus court costs.
